

Update of Client Identification Data concerning the Hong Kong Investor Identification Regime and Over-the-counter Securities Transactions Reporting Regime 有關香港投資者識別碼制度及場外證券交易匯報制度的客戶識別信息更新

According to the rules and requirements of the Stock Exchange of Hong Kong ("SEHK") and the Securities and Futures Commission ("SFC"), under the Hong Kong Investor Identification Regime and Over-the-counter Securities Transactions Reporting Regime, we Changjiang Securities Brokerage (HK) Limited are required to collect the up-to-date client identification data ("CID") from you, and the waterfall of identity documents acceptable as the CID in order of priority is as follows:
